
Annual Church Survey

- 71% have been members for 10 or more years


Covid-19 Vaccine Status





Registering Attendance


38% of Respondents are not registering their attendance when they worship in person or online.




Patterns of Attendance – Worshipping In Person



Practicing Our Inside Out Habits




Future Plans to Serve at St. Luke's








